Planning and Zoning Commission Meeting

Wednesday, March 1, 2023 at 6:30 P.M.

In a meeting room in the Washington library in Five Points - 380 N. Wilmor Road, Washington

- Call to Order** Chairman Mike Burdette called the regular meeting of the City of Washington Planning and Zoning Commission to order at 6:47 p.m. A quorum was established.
- Roll Call** *Present:* Commissioners Burdette, Milot, Ritter and Williams
Absent: Commissioners Reeder, Scott and Shelton
Also present: Planning and Development Director Oliphant, Planner Paque and City Clerk Brod
- Approve Minutes** Commissioner Milot motioned, and Commissioner Williams seconded to approve the meeting minutes from the February 1, 2023, as presented. Motion carried by voice vote.
- Public Comments** None provided.
- Public Hearing** *Request WACR Properties to rezone 115 N. Cummings Lane*
At 6:48 p.m., Commissioner Burdette opened the public hearing to consider a Request by WACR Properties, LLC, to Rezone 115 N. Cummings Lane from I-1 to C-3.
P&D Director Oliphant explained that Core and Main occupied the property previously but moved to a new location. He shared that pending approval a development would include a restaurant and a future retail use. He also shared that Core and Main occupied the property since about 1970. Mr. Oliphant stated that the property zoned I-1 is the only property in that area except for a parcel near the Uftring lot. All other properties in that area are zoned C-2 or C-3 and have some commercial use on the properties. This property is about 3.2 acres, has a primary access on Cummings and a secondary means to access from Essig Drive. Mr. Oliphant noted that this request is consistent with the comprehensive plan, for general commercial and is consistent with the other properties. He shared that they would like to demolish the current building and start clean. He also shared that the City can then review any stormwater or drainage concerns. Mr. Oliphant introduced Mike Seghetti who is representing the applicant. Mr. Seghetti feels this is an appropriate zoning for the lot and stated that he can answer any questions. Chairman Burdette closed the public hearing at 6:34 p.m.
- Commissioner Milot motioned to accept the requests; Commissioner Williams seconded.
- Chairman Burdette stated that this seems like an appropriate change.
