**Agenda Item:** Resolution – Approving Joint Funding Agreement with IDOT

**Explanation:** The City was selected for the STBG funds for the Freedom Parkway Extension project. IDOT requires that the city cover all costs over the grant amount. This resolution approves a joint agreement with IDOT that the City will pay for whatever costs go above and beyond the grant amount. The grant for the Freedom Parkway Project is \$2.15 million and the City is required to pay for everything beyond that.

**Fiscal Impact:** The City has budgeted for \$4,500,000 towards this project within FY 23/24 and the remainder will be budgeted in FY 24/25.

**A RESOLUTION APPROVING A JOINT FUNDING AGREEMENT WITH ILLINOIS DEPARTMENT OF TRANSPORTATION**

**WHEREAS**, the City of Washington endeavors to extend a segment of Freedom Parkway (FAU 6745) from the existing eastern terminus to Cummings Lane (FAU 6728) that is approximately 0.80 miles in length and known to the Illinois Department of Transportation as Section Number 20-00128-02-PV and State Job Number C-94-028-21; and

**WHEREAS**, the cost of said improvement has necessitated the use of federal funds;

and **WHEREAS**, the federal fund source requires a match of local funds;

**WHEREAS**, the use of federal funds requires a joint funding agreement with the Department of Transportation;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS**, as follows:

That the City authorizes four million five hundred thousand (\$4,500,000), or as much of such sum as may be needed to match federal funds in the completion of the aforementioned project known as Section Number 19-00128-02-PV.

BE IT FURTHER RESOLVED that the *Mayor* is hereby authorized and directed to execute the above-mentioned AGREEMENT and any other such documents related to advancement and completion of said project.
