Public Hearing

Item A: Request of Roni Roos for a variance to allow an 8' tall privacy fence in rear yard at 1513 Flossmoor Ave. At 6:31 p.m., Commissioner Burdette opened the public hearing to consider a variance request to allow an 8' tall privacy fence in rear yard at 1513 Flossmoor Avenue. Building and Zoning Coordinator Boyer explained that this is just one section, up against a neighbor's fence and it is for privacy and aesthetics.

At 6:32 p.m. Commissioner Burdette closed the public hearing.

Commissioner Ritter motioned to approve the request; Commissioner Scott seconded.

The petitioner, Ms. Roos explained that the top of the neighbor's fence could be seen if this isn't extended taller. She also shared that it only blocks the deck area and not the chain link. Commissioner Burdette confirmed that it would not encompass the whole yard, like cases in the past. Commissioner Reeder supports the request so long as it isn't extended further than the neighbor's fence and the neighbor, he is okay with it. Commissioner Scott clarified that it will be placed inside of railing. It was noted that the rest of fence is 6 feet tall. Commissioners Milot and Scott explained that they should specify the exact distance and height. Commissioner Reeder and Mr. Oliphant reviewed the distance of the neighbor's fence from the house. Mr. Oliphant noted that this matches up to the other fence. Commissioner Scott requested that this fence not exceed 12' in length.

Commissioner Ritter amended his motion to approve the request to include that the fence be no more than 12 feet in length; Commissioner Scott seconded
