**Explanation:** Staff solicited bids for the construction of new sidewalk along Eagle Avenue from the Central Intermediate parking lot to the intersection of Business 24.

A bid opening took place on June 27, 2024 at 10 AM at City Hall with two bids submitted.

As requested, we have reviewed the two (2) proposals received at the bid opening held at City Hall on June 27, 2024 for the above noted project. A summary of the bid tabulation is attached. C&G Concrete Construction Co., Inc. submitted the apparent low bid in the amount of \$109,852.00. This amount is 2.5% higher than our opinion of probable construction cost of \$107,160.00 and therefore we consider it a reasonable bid.

C&G Concrete Construction Co., Inc. appears to have fully completed their bid proposal and submitted the necessary executed forms with their bid proposal. They submitted a bid security in the form of a Bid Bond for 5% of the Amount Bid from a surety company certified to do business in the State of Illinois. C&G Concrete Construction Co., Inc. as a corporation, included all necessary signatures and dates. Therefore, we find C&G Concrete Construction Co., Inc. to be both 'responsive' and 'responsible' as defined in the bidding documents and recommend the City of Washington accept the bid proposal from them and award the Contract to them in the amount of \$109,852.00

Upon notification that the City approves the bid, we will deliver the Notice of Award along with the Contract and Contract Bond forms to C&G Concrete Construction Co., Inc. for their execution.
