Agenda Item: Second Reading Ordinance - Authorizing the Sale of Surplus Property

Explanation: The City has received the new Lin #1 Plow Truck. Truck Centers Inc. declined to offer

a trade value on the old Lin #1 unit. Lin #1 has been declared surplus property and staff

needs authorization to sell it.

AN ORDINANCE AUTHORIZING THE SALE OF ONE USED INTERNATIONAL 7400 TRUCK, COMMONLY KNOWN AS LIN #1 DESIGNATED AS "SURPLUS PROPERTY"

WHEREAS, on the 17th day of June, 2024, the Corporate Authorities did declare one used International 7400 truck, commonly known as LIN #1 to be "surplus property" since same was no longer necessary or useful to the City of Washington in its operations or in the performance of its programs or services; and

WHEREAS, it is in the best interests of the City of Washington and its residents that said surplus property be sold.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS, as follows:

- **Section 1.** That the used International 7400 truck, commonly known as LIN #1 and previously designated by the Corporate Authorities as "surplus property" shall be sold in the manner as described herein.
- **Section 2.** That the City Administrator shall determine the best means of disposition of the surplus property as deemed appropriate and necessary.
- **Section 3.** That the City Administrator shall keep a complete inventory of the used International 7400 truck in such detail as will be necessary to verify the proper and lawful disposition.
- **Section 4.** That the Bill of Sale hereto attached, marked Exhibit "A", and by reference expressly made a part hereof, be, and the same hereby is, approved for use in connection with the sale of said truck, and that the Mayor and City Clerk be, and hereby are, specifically authorized to enter into and execute the Bill of Sale in substantially the form of the document attached hereto, marked Exhibit "A" and by reference expressly made a part hereof for the transfer and sale of said used truck.
- Section 5. That this ordinance shall be in force and effect from and after its passage and approval as provided by law.
- **Section 6.** That the ordinances or parts thereof in conflict herewith are hereby expressly repealed.
