All interment fees include an additional \$110 for services that begin after 2:00pm.

In addition to the interment fees, additional burials on a gravesite will be charged a \$110 multi-use fee in lieu of purchasing separate grave. This fee will be charged at the time of need.

Grave prices and interment/inurnment fees increase \$10.00 every May 1<sup>st</sup>.

### GRAVE SALES

A down payment is required of one half the total cost for grave sites that are purchased prior to the time of need. The remaining balance may be paid within 90-days from the date of purchase without interest. Following the interest free 90-day period, an additional 90-day period is available in which to make payments that would be subject to 18% interest per annum back to the date of purchase. Failure to make the required payments or to pay in full within 180 days will result in forfeiture of the unpaid grave sites.

Holidays Include: New Year's Day, Memorial Day, July 4<sup>th</sup>, Labor Day, Thanksgiving, Christmas, and Christmas. Observed holidays include days when City Hall is closed to observe a holiday. The City has the right to prohibit burials during public events held in the Glendale Cemetery.

Gravesites can accommodate up to three burials on one grave. This can include one traditional/casketed and two cremations or three cremation burials.

### DISINTERMENT FEES

Disinterment fees mirror interment fees. See Interment Fees for pricing.

- all forms, permits, etc., are the responsibility of the applicant
- all disinterment/reinterment fees must be paid in advance of service
- fees are for cemetery expenses only - other costs such as but not limited to funeral homes, vault companies, and monument companies are the applicant's responsibility

### TRADING/EXCHANGING SITES & LOTS

For 1-4 grave sites:	\$50.00
For 5-8 grave sites:	\$75.00
For 9 or more grave sites:	\$100.00

### CEMETERY RULES & GUIDELINES

City personnel will perform all excavations for burials taking place at Glendale Cemetery. A concrete vault must be used for full burial. A vault is not required for burial in the infant section or for cremations.

- Bench monuments are allowed in lieu of a standard monument and must be placed at the head of the grave.
- Headstones, slabs and monuments which have fallen or which require repairing may be removed or the condition corrected by order of Glendale Cemetery unless removed or repaired by the owner.
- Glendale Cemetery may prohibit any contractor or workman from working in the Cemetery if such contractor or workman prove to be unreliable or incapable or if he/she refuses to abide by the rules and regulations.

- Private contractors and others will be held responsible for any damage done to lots, graves, paths, roads, plantings, trees, structures, etc., including damage to the lawn, and shall take all necessary precautions to avoid damage.
- Spreading of cremated remains will not be permitted.
- All remains must be interred in a solid container.
- Burials of any kind are performed by Glendale Cemetery personnel only.
- The City of Washington is not responsible for the recording of any deeds/contracts that take place outside of City knowledge. It is the responsibility of the interment rights owner to notify the City of Washington of any sale or transfer of interment rights.
- An individual may place graves on hold for a maximum of 30 days. After 30 days, any grave not purchased may be retuned for sale.
- The City of Washington is not responsible for the damage of any personal/extra items placed upon a grave, headstone or marker caused by the normal daily maintenance of the cemetery.
- The City of Washington is not responsible for the damage to headstones or markers resulting from normal cemetery maintenance near or on poorly or incorrectly installed headstone or markers.

#### UPRIGHT MONUMENT SECTIONS

The planting of non-woody plants on private burial plots is permissible with the consent of the person or family holding the interment rights. Planting is restricted to the 2 ft. x 4 ft. headstone area. Please contact cemetery personnel in advance of any planting on burial plots.

Decorative items such as artificial plants, statuary, shepherd hooks, fencing, etc. must be confined to the designated 2 ft. x 4 ft. headstone area. Markers in addition to a headstone must be flush with the ground (*Military markers provided by the V.A. are not subject to this rule.*) Structures other than monuments, such as benches, are not allowed on the grave site. Glendale Cemetery personnel reserve the right to remove any live greenery decoration that has subsequently turned brown, as well as any artificial decoration that is detached or in disrepair.

#### MEMORIAL GARDEN SECTION

The Memorial Garden sections have restrictions as follows:

- Only flat headstone markers are allowed.
- No plantings are allowed.
- Shepherd hooks and flower vases are allowed and are restricted to the headstone area of the grave, no other decorative items are allowed. If the headstone marker does not have a vase as part of the marker, we will allow ground vases to be placed in the ground immediately adjacent to the marker only.

### COLUMBARIUM

No decorations can be placed on or adhered to the columbarium by anyone other than Glendale Cemetery personnel. Please see additional information regarding columbarium specifications.

### PLANTING RULES & GUIDELINES

The planting of all trees, bushes, shrubs and other woody plants of any type is prohibited in Glendale Cemetery, except by authorized city personnel. This woody plant restriction applies to both the public areas of Glendale Cemetery and private burial plots. The City has a long-term landscaping and tree planting plan for the cemetery grounds and accepts cash donations to help defray planting and landscaping costs. The Cemetery Tree Plan is available on the City website or at City Hall upon request.

- Glendale Cemetery staff reserves the right to use their discretion to make this determination.
- Holiday blankets are allowed during the winter months.
- Floral and other artifacts and displays are allowed within one (1) foot of the headstone.
- Glendale Cemetery is not responsible for lost or stolen flowers, artifacts or displays.
- No decorative rock, woodchips or fence is allowed.
- Glendale Cemetery reserves the right to remove any live greenery decoration that has subsequently turned brown, as well as any artificial decoration that is detached or in disrepair.
