Chief Brown was unable to attend the meeting but submitted the Washington Fire Department Monthly report. Chief McCoy responded to questions ...all was good with the Fire Department.

G. Other Business

Chairman Adams asked about the use of the Police Motor Units and if the Police Department was keeping track of usage. Chief McCoy responded that a form had been created and the Police Department was keeping track. That report will be added to the Washington Police Monthly Report.

Chief McCoy asked if the Committee would be willing to discuss the salary of Deputy Chief Jeff Stevens because he believes there is a big discrepancy that needs addressing. The Committee agreed and it was later determined that the matter would go to the Finance Committee. Chief McCoy was asked to check the lighting on the top of fire ambulances.

Grant Update:

Federal Grant

The Washington Police Department has recently submitted a federal grant for the Evidence Building thru Congressman Lahoods office. Since Washington is going to be receiving one grant we are hoping the Evidence Building will sway some votes to get us the second grant. Thanks to Congressman Lahood for submitting two grants for Washington for approval from the Appropriations Committee.

State Grant

Washington has been approved for a 200,000.00 \$ Grant from the State of Illinois. 100K for the Washington Fire Department and 100K for the Washington Police Department. There have been some struggles with the State on the Grant. Joanie Baxter has been in constant contact and we feel confident the grant will become active soon. We need hope this happens because the money is designated for new radios for the system that will soon be in place.

Employee Update

New employees Tanner Stockton and Ashley Peto have both graduated from Police Training in Champaign and are working the different shifts with our field training officers. Both are highly respected already and are learning Washington at a rapid rate. I would like to introduce both Officers at next Mondays City Council meeting.

That leaves us with two openings. The Police Commission has a new certified list and the top two candidates are lateral entry qualified. Backgrounds are being done on them right now. As soon as backgrounds are finished the Commission has a final meeting and if all is good...we can offer conditional employment. (Physical and polygraph). If that works out... we will offer employment positions and they can start right into the Washington Police Training.

A position for part time PASS exists. Our current Intern has applied for the position. Her background was just completed and we are going to offer the part time position.

We have a Sergeant who is currently taking off until the 26th of this month and is contemplating his retirement date .He has stated that he might take the months of December and January totally off... since he has the earned time coming. So, what I would like to do...promote a patrol officer to Sgt. Now...let him get trained then the overtime would not fall upon 4 sergeants...it would fall on the patrol officers since that

where the shortage would be. The rate would be cheaper and the stress would fall on 3 times as many people.

Mental Health Review

As you are aware the, new state law mandates that all police officers will be evaluated by a qualified mental health provider, once a year. (I might add...an unfunded mandate).. Deputy Chief Stevens and I were both evaluated last week. It is Confidential and after all officers are evaluated we are given an overall report as to any deficiencies that the evaluator finds...so we can make changes in training. Time is 2 hrs per officer, at overtime rate.

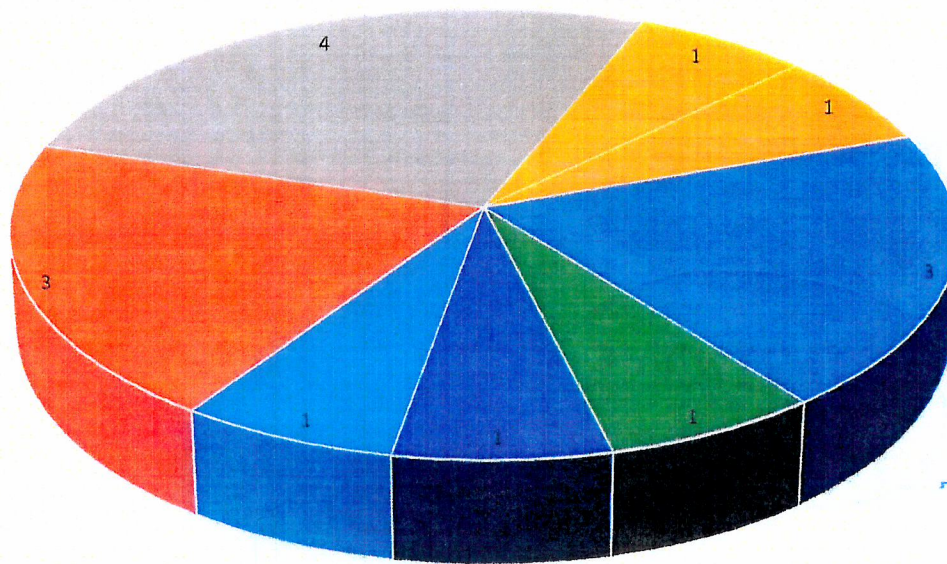
